Charitable Bequest – Information Sheet

Overview

When most people think about leaving a legacy to their favourite charities, they often consider making a bequest in their will. The following information can help you decide if making a charitable bequest to Rainbow Resource Centre is right for you.

You can make a bequest for:

- A specific dollar amount, or specific assets such as securities
- The remainder of the “residue” of your estate (i.e., what is left over after your other bequests have been fulfilled)
- A percentage of your estate
- Your entire estate
- A contingent bequest that passes to Rainbow Resource Centre in the event that your primary beneficiary predeceases you

Some types of bequests, such as a specific dollar amount, are straightforward and can’t be challenged. Others, like the residue of your estate or a percentage of your estate may have to be settled in probate. Please speak with your accountant, lawyer, and/or financial advisor about what type of bequest to Rainbow Resource Centre would work best for you and your heirs.

Possible Wording for Your Will

The following is sample language for including a gift in your will to Rainbow Resource Centre:

- To give a specific amount: “I bequeath the sum of _____ dollars (\$_____) to Rainbow Resource Centre, 170 Scott Street, Winnipeg, MB R3L 0L3.”
- To give a percentage of your estate: “I bequeath _____ percent (____%) of the rest, residue, and remainder of my estate to Rainbow Resource Centre, 170 Scott Street, Winnipeg, MB R3L 0L3.”
- To give a specific asset, such as shares in a company: “I bequeath _____ shares of _____ [full name of company] to Rainbow Resource Centre, 170 Scott Street, Winnipeg, MB R3L 0L3.
- For a gift contingent upon a certain condition: “In the event that _____ [full name of family member(s)] does/do not

Benefits of a Charitable Bequest

- There is no immediate cost to you, so your gift won't reduce what you have to live on
- You could make a bigger gift than what may be possible during your lifetime
- Gifts made in your will can reduce or even eliminate the final income tax payable that would otherwise reduce what you leave to your heirs

Codicils and Amendments

Rainbow Resource Centre will provide you with information and assistance to make a bequest in your will. However, the ultimate responsibility regarding evaluations, tax deductibility, and/or similar legal, local, provincial, or federal compliance issues rests with you and/or your counsel.
